She was kept under observation till June 16, 2021 when she was discharged with her baby with advice to remove the suture after three days.</p> <p>It was the time for second wave of Covid. The patient did not visit the CE again and got the suture removed at her residence.</p> <p>On June 21, 2021 she was taken to Amadpur Hospital wherefrom she was referred to Immambara Hospital where she stayed for few hours and then to a</p>

		<p>private nursing home on June 22, 2021 wherefrom she was shifted to Kolkata where she was treated at a private hospital for about 11 days.</p> <p>She was diagnosed Septicaemia with multi-organ failure as would appear from the discharge note given by the CE.</p> <p>The complainant is now cured and is under constant check-up.</p> <p>She would complain as against the first CE for lack of care.</p> <p>Her grievance mainly relates to the concerned Gynaecologist who was responsible for fixing the suture that got infected.</p> <p>We understand, she has already approached the West Bengal Medical Council.</p> <p>Let such complaint before the West Bengal Medical Council, reach a logical conclusion.</p> <p>In case she is successful she would be at liberty to</p>
