	1.	21/12/2023	<p>This complaint would relate to wrong USG report.</p> <p>The complainant would contend, because of the wrong report he had to travel to Hyderabad for treatment by spending huge sum of money to exclude the possibility of Pancreatitis as suggested in the report.</p> <p>In course of hearing, Mr. Pritam Sarkar representing the CE, would offer Rs. 80,000/- to ameliorate the grievance of the complainant. He would also pray for instalment. The complainant accepts the offer.</p> <p>The complainant is directed to share his bank details so that money can be paid in four equal monthly instalments by bank transfer.</p>





			<p>The first of the such instalment would be paid on January 15, 2024 and thereafter on the 15<sup>th</sup> day of the each succeeding months.</p> <p>In default of payment of any one instalment the balance amount would become immediately payable along with interest at the rate of seven per cent per annum until realisation.</p> <p>The complaint is disposed of.</p> <p>Before we part with we would be failing in our duty if we do not take appropriate steps in a case of glaring illegality that we find from the report.</p> <p>The concerned doctor who has signed the report, has described himself as MBBS, MD, (Cal) Consultant Radiologist, Registration No 55582 (WBMC).</p> <p>In course of hearing it appears that he has obtained his post graduate degree from Katihar and not from Kolkata and that too, in Pathology and not Radiology.</p> <p>The concerned doctor is present online.
