






		<p>Biplab Bhatta Rai on behalf of the CE.</p> <p>We have also considered the response submitted by the CE admitting their mistake.</p> <p>They would contend, it was a typographical mistake.</p> <p>We are not sure, whether it was a typographical mistake or not as our expert would clarify, every report, before it is handed over to the patient, is verified with the note of the Radiologist as well as the film so that such mistake does not occur.</p> <p>In this case it was not done. It is a grave negligence on the part of the CE.</p> <p>We impose a penalty of Rs. 25,000/- that the CE would pay to the patient on bank transfer.</p> <p>We direct the complainant to share the bank details of the patient so that money could be transferred at once.</p> <p>The complaint is disposed of accordingly.</p>
