	1.	06/01/2025	<p>A 67 year old male patient was admitted at the CE on September 1, 2024 with the history of high grade fever for last two days associated with multiple episodes of vomiting and nausea. As per the discharge summary, the patient had type II diabetic mellitus and hypertension that the complainant would strenuously deny.</p> <p>The patient was discharged on September 12, 2024.</p> <p>According to the complainant, the patient was totally un-conscious and was not fit for discharge whereas Dr. Anand present online, being the treating doctor, would contend, the patient was in his sense. He was discharged after being found to be hemodynamically</p>





		<p>stable.</p> <p>He was immediately shifted to another hospital where he died on September 14, 2024 after two days hospital stay.</p> <p>The complainant would contend, his father was admitted after having fever. He was neither diabetic nor had any hypertension. These were incorporated by the CE only to inflate the bills.</p> <p>He would seriously question the treatment protocol as recorded by the CE in the discharge summary.</p> <p>According to the CE, his haemoglobin was 8.7 on September 7, 2024. It was quite normal and as such test was not repeated whereas at the second hospital he was found be to having anaemia having 5.7 haemoglobin .</p> <p>The complainant would contend, he did not select the treating doctor. He went to the hospital for his father's treatment and the Hospital introduced Dr. Anand to him for the treatment. According to him, during his father's stay at the hospital, he would find, Dr. Andand was the</p>
