He would submit, he is running polyclinic at the premises which is under litigation as referred to above.</p> <p>At present, three doctors namely Dr. Souryodeep Sadhu, Gynaecologist, Dr. Subrata Sarkar, Laparoscopic surgeon &amp; Dr. Parasambhik Mukherjee, Orthopaedic surgeon are regularly giving OPD service to the patients visiting the polyclinic.</p> <p>He would assert that there is no in-house facility in the said polyclinic.
