The baby was born and the patient was shifted to general ward. Subsequently, the patient had post operative complication for which she was transferred to ICU. Ultimately there was multi-organ failure resulting in ultimate death of the patient.</p> <p>According to the CE, they work in a group of a team of doctors.
