	1.	04/06/2025	<p>The complaint would pertain to very very unfortunate death of a young 18 years old boy who was suffering from deviated nasal septum with sensiliary sinusitis and polyps.</p> <p>The patient was seen by Dr. Dipankar Dutta who advised surgery to be done. Accordingly, the patient was admitted at Panacea Nursing Home, Barrackpore. In course of surgery there had been anaesthetic complication and surgery could not be completed. The patient was shifted to ICU. Subsequently, he was transferred to Manipal Hospital, Salt Lake where he breathed his last.</p> <p>Our esteemed medical member, Dr. Sukumar Mukherjee, has interaction with Dr. Dipankar Dutta, ENT</p>

surgeon as well as Dr. Sanjay Kumar Singh, Anaesthetist.

According to Dr. Mukherjee, the patient should have been examined by a physician before taking a final decision for surgery as according to him his IGE marker was indicator of hypersensitivity that is very much raised.

The complainant, the uncle of the deceased patient, would have serious grievance as against the CE with regard to infrastructure as well as lack of counselling.

We also understand, the complainant has already approached the West Bengal Medical Council questioning the medical issue resulting the unfortunate death of the patient.

We feel, it would be fit and proper, we should wait for a decision from the West Bengal Medical Council.

In case the complainant gets a favourable response he would be at liberty to approach us afresh as against the CE for appropriate relief.

The complaint is disposed of.


