	1.	22/09/2025	<p>The complaint would relate to difference of medical opinion between two doctors.</p> <p>Our esteemed medical member Dr. Sukumar Mukherjee has interaction with the complainant. According to Dr. Mukherjee, although there had been a technical difference that was not so much important. CT Angiogram is more sensitive and less specific. Invasive Angiogram is more specific and gold standard for invasive treatment. Moreover, the patient was not diabetic or</p>





hypertensive which are usual risk factor to accelerate coronary heart disease. Invasive Angiogram, single ton of LAD 70-80 percent, does not usually come under the category of severe critical stenosis.

In any event, the difference, if any, between the two doctors did not have any serious consequence on the patient.

Yet, in case the complainant has any grievance as against the medical protocol he is free to approach the appropriate authority for the same.

In case he succeeds therein, he would be at liberty to approach us afresh as against the CE.

The complainant has further grievance as against the CE.



A clinical report was expected to reach him within the assured time that the CE miserably failed.

Dr. Gourdeep Bhattacharya, the medical superintendent, would submit, although both the clinical establishments are under the same management these are two separate entities and it was difficult to get the other establishment involved where the patient had Angiogram. Hence, the delay.

Dr. Bhattacharya would express regret for the same.

We hope and expect, they would send a letter of apology for such delayed response.

The complaint is disposed of accordingly.
