	01	25-04-2018	<p>Although the representatives of the Clinical Establishments and their learned Advocates are present, but none appears on behalf of the complainant, nor any accommodation has been sought for.</p> <p>This is a case where the service recipient is common. He was treated successively at Medview Nursing Home and at R-Fleming Hospital and then expired. Alleging medical negligence in treatment, while the father of the service recipient Mr. Abani Karmakar lodged a complaint against Medview Nursing Home, Mr. Ajoy Bhusan Karmakar, the uncle of the service recipient lodged another complaint against R-Flemming Hospital.</p> <p>Subsequently, on April 20, 2018, the Commission received a letter from Mr. Abani Karmakar, expressing his desire not to proceed with his complaint. Prior to the receipt of the aforesaid letter dated April 20, 2018 from Mr. Abani Karmakar, another letter dated January 9, 2018 was received by the office of the Commission from Mr. Ajoy Bhusan Karmakar, intimating the Commission that he was not intended to press his complaint and desired to withdraw the same.</p> <p>However, on this morning (April 25, 2018), Mr. Ajoy Bhusan</p>

Karmakar submitted a letter at the office of the Commission, requesting to fix another date for hearing as he is ill.

Having regards to the above, the complaint filed by Mr. Abani Karmakar, the father of the service recipient, in terms of his letter dated April 20, 2018 and communication received thereunder, the Case No. NPG/2018/000291 stands dismissed as withdrawn.

However, as prayed for by the complainant of Case No. KOL/2018/000279, Ajoy Bhusan Karmakar, uncle of the service recipient, vide his letter dated April 25, 2018, the hearing stands adjourned for this day.

The next date of hearing shall be communicated to Mr. Ajoy Bhusan Karmar and the Clinical Establishment by the office in due course.
