	5.	27/04/2018	<p>In spite of notice of hearing neither the complainant nor anyone on her behalf is present. However, the Clinical Establishment is represented by their learned Counsels. Mr. Suranjan Ghosh, General Manager (Operation) and Dhrubajyoti Mishra, HR and Legal are present.</p> <p>On 5<sup>th</sup> April, 2018, a letter has been received by our office from Mr. Mahibur Rahaman, the power of attorney holder of the complainant, Bulbul Begam intimating the Commission that they are no longer inclined to press the complaint.</p> <p>In this regard, it be noted that complaint dated 22.11.2017 was received at our office on 04.12.2017 and on the very day, i.e., on 04.12.2017 notice was issued to the Clinical Establishment and the medical file of the service recipient was called for. Thereafter, at the earliest opportunity on 10.01.2018, the case was first posted for hearing. On that day, after hearing the parties, the Commission directed them to present their respective cases in the form of affidavit. Then again, on 21.02.2018, matter was listed for further hearing. On that day, on the prayer of the power of attorney holder of the complainant, one month's time was granted to him for filing the supplementary affidavit disclosing their case in more detail. 		<p>said affidavit was filed and matter was listed for hearing on 04.04.2018. On that day, over the service of the copy of the said affidavit upon the Clinical Establishment, some hot altercation took place between Mr. Mahibur Rahaman and the representative of the Clinical Establishment and their learned Counsel and the complainant, Mr. Mahibur Rahaman and another who was present on the side of the complainant left the hearing room.
