	01	04-07-2018	<p>The complainant Mr. Arpan Mondal is absent and is represented by his elder brother Mr. Bipul Mondal.</p> <p>On the other hand the Clinical Establishment is represented by their Learned Counsel Mr. Soumendranath Ganguly. The power filed by Mr. Ganguly be taken on record. Both the Treating Doctors, Dr. Biman Kumar Chakraborty – HOD Gynecology , Dr. Nidhu Ranjan Mandal, are also present.</p> <p>Complainant is the nephew of Mrs. Sumitra Mandal, the service recipient. On 03.6.2017 said Sumitra Mandal was admitted at Swaraj Gupta Cancer Centre and Research Institute at an advanced stage of Cancer (carcinoma in ovary) and expired on 09.06.2017. It is the further case of the complainant although, during her stay at the said centre, biopsy was done but the histopathology report was not supplied with the discharge certificate and the medical files, as a result their mediclaim has not been processed.</p> <p>The Learned Counsel appearing on behalf of the Clinical Establishment submits that the said report is with him and ready to hand over the same to the legal representative of the service recipient subject to production of proper documents.</p>



Having regards to the submission of the learned Counsel for the Clinical Establishment, we are of the opinion that this case can be disposed of here and now, without any further hearing, directing the complainant to obtain necessary authorization from the husband of the deceased service recipient, Sumitra Mandal and on production of the same, the Clinical Establishment shall supply the histopathology report to him.

Accordingly, this complaint stands closed and disposed of.

Office is directed to return the original medical files containing the Biopsy report to the Respondent Clinical Establishment.

We have been informed by the office that the Xerox copies of the entire medical files are already with the records.
