			Establishments. The Northern Light Hospital Private Limited did not,
			however, file the entire records. They assure us, they would do so
			within a week from date.
			We understand, the complainants have already approached the
			West Bengal Medical Council as against the treating doctor of both
			the establishments. We are also told, they have already approached
			the National Consumer Forum for appropriate compensation as
			against the treating doctors as well as the Clinical Establishments.
			The National Consumer Forum directed AIMS to evaluate the

medical record. They have done so and submitted a report that is kept on record. The West Bengal Government, through Health Department, also got the medical records evaluated through a Committee of experts, a copy of the same is also kept on record.

We have perused both the reports where the definite cause is yet to be found out. The petitioner wants to pursue their remedy before the National Consumer Forum. We cannot simultaneously proceed with the complaint when National Consumer Forum is also considering same complaint for appropriate compensation.
