	1.	12/02/2020	<p>This complaint would pertain to medical negligence. In course of hearing Dr. Prabir Mukherjee, ICU In-charge and Mr. Swarup Dey, representative of the management of the Clinical Establishment volunteers to pay a sum of Rs. 2,00,000/- to the concerned patient within a period of one month from date and further sum of Rs. 3,00,000/- within a period of six months there after. Such compensation is paid in deference to the desire of the Commission. The complainant, the father of the ill fated child, is present. He is willing to accept the said compensation on behalf of his son who unfortunately lost a part of his right leg which was amputated because of gangrene.</p> <p>We do not wish to proceed with the application in view of such conscientious being arrived at we hope and trust, the Clinical Establishment would make appropriate investment of Rs. 2,00,000/- at Kholakhali Post Office, Jainagar in the name of the minor patient Hasanur Jamal Laskar, son of Abdul Halim Laskar, the complainant abovenamed. Such investment must be renewed from time to time</p>



together with the proceeds thereof till the boy attains the age of majority. The Hospital Authority would also make a further fixed deposit and/or investment for balance of Rs. 3,00,000/- within the time stipulated above, in the same manner as directed above.

In default, the complainant would be free to approach us for appropriate direction.

The complainant assures us, in case he would receive the compensation on behalf of the ill fated boy he would not proceed as against the Clinical Establishment and/or the doctor before any other forum.

The complaint is disposed of accordingly.
