The West Bengal Clinical Establishment Regulatory Commission
(WBCERC) issues the following advisory

A D V I S O R Y - 25

It has been noticed by the Commission that there has been an ominous rise in Covid cases in recent days . Clinical Establishments have taken measures to enhance the bed capacity. Yet, the present capacity in CEs is unsatisfactory and failing to fulfill the requirements .. Now, it is apprehended that many precious lives may be lost if COVID beds are not enhanced to accommodate the increasing no of patients . Against this backdrop, it has become extremely urgent to take steps and further




enhance the bed capacity. With this objective under consideration, the following advisory is issued as an emergency measure to enhance covid beds to deal with the epidemic effectively .

1. All the Clinical Establishments in the private Health Care sector would be segregating 40% of the total sanctioned beds including Day Care Beds, Emergency triage, for emergency non-Corona treatment like Dialysis and Emergency Surgeries. The rest , being 60 % of the sanctioned beds /set up , would be dedicated for Covid treatment.
2. The Commission has noticed that the majority of the clinical establishments has already enhanced their Covid bed strength to cope with the present situation. In case, such strength has already exceeded 60%, that must not be disturbed , meaning thereby, there would be not a single case of reduction in the number of beds already dedicated for Covid treatment.
3. This advisory, however, will not be applicable to CEs wherein Govt has requisitioned Covid beds or CEs serving as charitable organization.



4. The step as mentioned, may be taken as early as possible and a report be submitted to the Department with a copy to the office of the Commission.
