

	1.	21/09/2022	<p>The complaint would relate to unfortunate death of a three year old patient who was admitted for her Herneotomy coupled with Orchidopexy. According to the CE the, patient suffered cardiac arrest immediately after the operation.</p> <p>Immediately thereafter, the patient was shifted to ICH. The CE would contend, they did not have idea why the patient was refused admission at ICH.</p> <p>The patient was subsequently taken to SSKM hospital where the patient was denied admission because of infrastructural deficiency as the PIKU was being fumigated at that time.</p>

			<p>The patient family ultimately approached the Medical College where the patient was found broad dead.</p> <p>The Police seized the dead body and all necessary medical records pertaining to the surgery. Post-mortem was done, the report is awaiting.</p> <p>The CE has shared a video photograph wherefrom we find that the doctors present there, were in conversation with the uncle of the ill-fated child, Shri Arindom Roy.</p> <p>The complainants would however, contend, the doctors seen in the video, are all junior doctors. Neither the surgeon nor the anaesthetist was present when Mr. Roy was counselled.</p> <p>The complainant has come before us with the complaint as against the CE. On perusal of the complaint, we find, the principal complaint would relate to medical negligence that would be outside our domain.</p> <p>We grant liberty to the complainant to approach West Bengal Medical Council as against the surgeon Dr.</p>
