

	1.	22/03/2023	<p>The complaint would relate to unfortunate death of a young girl of five years old. The baby had a Dentoalveolar abscess for which pulpectomy and dental extraction were planned.</p> <p>The dental surgeon was consulted who advised admission in hospital. On the fateful day, the surgical team took the child to the OT however due to anaesthetic complication the child got critical and ultimately passed away.</p> <p>The complainant, mother of the ill fated child, has approached us as against the CE on two counts : the first being the establishment did not have intensive care for the child being PICU and the second as the OT was not</p>





		<p>properly equipped.</p> <p>We are informed, the complainant has approached Medical Council as against the surgical team. In our view, she should also approach the Dental Council for identical grievances.</p> <p>Post mortem was done. The report reveals, the patient died of Hypoxia however, final opinion would depend upon Histopathological report that is still awaiting.</p> <p>We have also heard Mr. Sanjoy Banerjee learned advocate assisting the complainant. Mr. Banerjee would contend, we should simultaneously consider the deficiency that the CE was having.</p> <p>We feel, interest of justice would be sub-served, if we wait for the Histopathological report as well as the decisions of both the Councils being Dental Council and Medical Council, if approached.</p> <p>The complaint is disposed of with liberty to the complainant to approach us afresh in case she is</p>
