

The patient had intra operative bleeding that the concerned surgeon could control however in the process, there had been huge blood loss that caused hypotension. The patient went into hypovolemic shock. The patient was taken to ICU and ventilated. He was subsequently transferred to another establishment in ventilated condition as per the insistence of a relative of the patient who happened to be a paramedical staff working in the next establishment.</p> <p>The complainant is present online through mobile</p>



		<p>phone on speaker mode.</p> <p>According to her, when she was called in the OT she would notice huge blood coming from the drain and that could not be stopped. The patient died at the next establishment within half an hour of his arrival.</p> <p>We have heard the concerned RMO, representing the CE. He would contend, the patient came to the hospital with a complain of pain abdomen. The patient was attended by the physician Dr. Udayan Das at OPD when Dr. Das advised surgery. He was subsequently referred to the concerned surgeon who did the surgery.</p> <p>The concerned surgeon is present online. According to him, laparoscopic surgery could not be possible because of adhesion. The patient family was properly counselled and it was converted into open surgery where bleeding could be noticed. Bleeding could ultimately be stopped however, in the process there had been huge blood loss. The patient went into hypovolemic shock and transferred to ICU and ventilated.</p>
